



2011 LISTED COMPONENT AGREEMENT

In consideration of the mutual promises and covenants herein contained, the following agreement is entered into this _____ day of _____, 20____ by and between the National Marine Manufacturers Association, Inc. a corporation organized under the laws of the State of Delaware and hereinafter referred to and described as 'NMMA', and:

a manufacturer of marine components, hereinafter referred to and described as the 'Manufacturer'. The purpose of this Agreement is to provide for the issuance by NMMA of Component Listing in the name of the Association for marine components produced by the Manufacturer for the **2011** model year.

The purpose of this Agreement is to provide for the terms and conditions under which marine products of the Component Manufacturers will be included in the NMMA Listed Component lists and NMMA website.

Listed Component lists are established for and limited to boat/yacht components, for which performance requirements are published in the American Boat & Yacht Council (ABYC) Standards, conformance to which cannot readily be ascertained by visual inspections.

Section I. NMMA agrees:

- A. To issue an NMMA Listed Component Identification Number upon the receipt of one or more of the following:
 - Acceptable test data from an independent laboratory
 - Acceptable test data from Component Manufacturer's test laboratory or R&D department
 - Other information specified by NMMA indicating conformance of the boat components to the requirements published in the ABYC Standards
- B. To notify Component Manufacturer of the Listed Component Identification Number.
- C. To furnish copies of the applicable Listed Component Lists to the Component Manufacturers upon request at the time of revisions.
- D. To furnish copies of the complete Listed Component Lists to NMMA member or NMMA Certified Boat and Yacht Manufacturers upon request.
- E. To maintain the Listed Component list available on the NMMA website

Section II. The Component Manufacturer agrees:

- A. To provide accurate test reports and information for each component submitted for Type Acceptance as required by NMMA.
- B. To pay NMMA according to the attached Listed Component program charges schedule (Schedule A).
- C. That any component listed is part of the accepted component for NMMA Listing per the eligible components schedule (Schedule B)
- D. To accept the sole responsibility for the accuracy and completeness of the test reports and information provided to NMMA.
- E. To hold harmless and also defend NMMA from any liability arising from errors in the provided information.
- F. To refrain from placement of an NMMA or any other logo representing the NMMA listing program upon the product or any packaging.
- G. To refrain from creating the impression in any trade or consumer advertising or publicity or other statements or written releases that such Component Listing is (1) exclusive to the manufacturer, (2) implies or constitutes any NMMA product endorsement, and (3) has any connotation as to the durability or any other characteristic of design or performance other than the factors for which it is actually Listed.
