


Figure 3. Number of Registered Boats by Zipcode within the Tennessee 4th Congressional District





Figure 4. Per Capita (Household) Ownership of Registered Boats by Zipcode within the Tennessee 4th Congressional District




Figure 3. Number of Registered Boats by Zipcode within the Tennessee 5th Congressional District




Figure 4. Per Capita (Household) Ownership of Registered Boats by Zipcode within the Tennessee 5th Congressional District






Figure 4. Per Capita (Household) Ownership of Registered Boats by Zipcode within the Tennessee 7th Congressional District
